94 MACKINTOSH AVENUE (DEP FILE #234-876) – NOTICE OF INTENT

Chris Bianchi, the Applicant, and Diane Simonelli, of Field Resources Inc., were present for the hearing. D. Simonelli provided an overview of the proposed work, which consisted of the demolition of the existing single family house and construction of a new single family house. The existing site consisted of lawn extending to the back of the property up to the bordering vegetated wetland and a shed within the 25-foot Buffer Zone. A subsurface stormwater unit was also proposed to capture the first inch of stormwater runoff from the new structure.

D. Anderson noted that test pit data had been provided by the Applicant. The Commission requested that special conditions be written into the Order of Conditions for signage around a small restoration area as well as preventing final grading from shedding to the neighboring property. Erosion control barriers and silt sacks were also provided in the proposal, to be incorporated into the Order of Conditions. A waiver for the restoration plantings within the 25-foot Buffer Zone was provided by the Applicant.
