Susan McArthur, McArthur Environmental Consulting, stated that the plan changes were submitted to the Commission. The Commission reviewed the revised plans and photos of the backyard.

- J. Carter Bernardo asked about the soil test hole for the subsurface infiltration system proposed where the chambers are and why that could occur at a later date. S. McArthur stated that the land is approximately 10' higher than the wetland in this area.
- J. Carter Bernardo asked about the increase of impervious area proposed within the riverfront area. S. McArthur stated that these numbers were included in the narrative. The existing lot coverage is 10.7% and the proposed is 13.8%.
