Call To Order - 6:30 p.m. - Carol deLemos
Carol deLemos, Vice-Chair, called the November 4,
2010 Council on Aging Board Meeting to order.

II. Approve Minutes:

Brenner Gutner stated that she is putting together a schedule for an initial audit and when this is completed she will update the Board. Discussion continued on the screen for "MySeniorCenter" and implementation of the functions available to us. J. Brenner Gutner suggested that Board members who experience difficulties with the site should contact her so that she could determine if it is something we can correct in house or if the web-master should be contacted. C. deLemos also suggested a gathering for Nina Silverstein and Derrek Shulman to acknowledge their years of service. The Board will continue this discussion in December with more members present.

V. Friends of the Needham Elderly, Inc. Report - Roma Jean Brown:

The Friends Report included an update on their joint meeting with the COA Board to discuss future fundraising efforts. Friends also discussed that their website is up and running. They have also sent a letter to various agencies and organizations regarding the need for a new van which resulted in a call from Dedham Savings, regarding a Foundation for which the Friends could apply for funding of up to \$10,000.
