III. Rail Trail Report - Tom Connors

Mr. Connors presented information on the Friends of the Needham Rail Trail Greenway's plans to transform Needham's old railway corridor. Mr. Connors shared with the COA Board similar greenway projects from other communities. Mr. Connors spoke about the opportunities the rail trail would provide to the community of Needham and how seniors could use the trail that would lead them to the New Senior Center. Mr. Connor outlined how the trail would connect Needham, to Newton and to Dover. A general discussion ensued on bridge crossing over 128, maintenance and future funding.

J. Brenner reported on her conversation with the Executive Director of MCOA(Massachusetts Association of Councils on Aging) about this issue. A general discussion ensued on the Circuit Breaker Tax Credit for homeowners and renters. A COA Board member expressed an appreciation for the upcoming, "Safe Talk Suicide Alertness Training for Everyone, " which will take place on March 21 in the Needham Public Library.

VI. Friends of the Needham Elderly (F.O.N.E), Inc. Report - Roma Jean Brown

No Report. F.O.N.E did not meet in February. Next monthly meeting will be at the beginning of March. A general discussion ensued on the resource network available to help seniors with plowing, and ensuring that people have supplies to help them through storms.
