The property had been sold before all of the Special Conditions had been met, and the previous owner stepped in to rectify the outstanding matters. There were some issues getting the mitigation plantings to take and the Applicant had previously met with Conservation Staff to review the plantings. At the time of the hearing the plantings had been installed and monitoring reports had been submitted. D. Anderson stated that they previously had trouble with the survival of the plantings, and only one growing season had been completed. A second monitoring report should be submitted in September after completion of the second growing season for consideration of a full Certificate of Compliance.
