Mr. Pingitore moved to authorize Jeanne McKnight and Peter Pingitore to act as liaisons and confer with the Planning Board, Conservation Commission, Historic Commission, Park and Recreation Commission, and Select Board and Town Manager regarding proposed amendments to the Needham Community Preservation Plan.
